According to this approach the main directions of assessment are collaboration, efficiency, qualification, and development, visibility and responsibility.

Mr. Ara Chalabyan also notes that since implementing this assessment process, IA department at CBA received two "generally conform" ratings from external quality assessments performed by colleagues from Dutch Central Bank — one in 2012 and another in 2017 — as well as mission-positive conclusions from an International Monetary Fund safeguards assessment. AUA student and CBA intern was awarded scholarship





Round Table Meeting


